NAMDIA and NAMPOL Strengthen Security Collaboration Through New **Memorandum of Understanding**

04 December 2025 - Namib Desert Diamonds (NAMDIA) and the Namibian Police Force (NAMPOL) today formalised a key partnership aimed at strengthening the security and integrity of NAMDIA's operational environment through the signing of a Memorandum of Understanding (MoU).

The MoU provides a structured framework for long-term cooperation between the two institutions and reinforces their shared commitment to safeguarding a strategic national resource. It outlines joint commitments to improve operational coordination, information sharing, risk management, rapid response mechanisms and security protocols across NAMDIA's diamond-handling processes.







It ensures that NAMDIA's internal controls remain aligned with international best practice, thereby supporting client confidence, investor trust and compliance with global security expectations.

The event held at NAMPOL Headquarters was attended by NAMDIA's top management and highranking officials from NAMPOL, signalling the collective commitment of both institutions to strengthening the protection of national assets.


